Imajući u vidu da je prošla godina pokazala da je vlast još uvek nespremna da se ozbiljno i odgovorno suoči sa brojnim problemima i sprovede kvalitetne reforme u ovom sektoru, ANEM, u saradnji sa advokatskom kancelarijom „Živković&Samardžić“ kao dugogodišnjim partnerom, nastavlja sa pravnim monitoringom medijske scene, nastojeći da pruži smernice za potrebne promene koje će omogućiti izgradnju optimalnijeg medijskog regulatornog okvira i stvaranje povoljnijeg okruženja za funkcionisanje medija i medijskog tržišta u Srbiji. ANEM takođe nastavlja i sa pratećim promotivnim aktivnostima – izdavanjem specijalizovane Publikacije, organizovanjem okruglih stolova i kreiranjem i slanjem *Monitoring Novosti*. **1. Pročitajte Devetnaesti Monitoring Izveštaj, objavljen na ANEMovom web sajtu!**

Prvi ovogodišnji Monitoring Izveštaj, *devetnaesti po redu*, sadrži rezultate pravnog monitoringa medijske scene u Srbiji **za period Januar – Februar 2011.**

Nalaz monitoring tima ukazuje na sledeće:

Novinari i mediji u Srbiji i dalje nemaju adekvatne uslove i okruženje za rad. Nastavljeni su pritisci, pretnje i drugi vidovi onemogućavanja njihovog nesmetanog rada, a nepovoljnoj atmosferi doprinosi i nepromenjena sudska praksa u medijskim slučajevima. Raste broj novinara kojima je dodeljena stalna policijska zaštita, a u ovom periodu im se pridružila i jedna predstavnica civilnog sektora. Regulatorni okvir u posmatranom periodu nije bio menjan, što je loša vest, jer su njegovi nedostaci i dalje prisutni i u praksi se nepovoljno odražavaju na medije. Nadležni organi i dalje ničim ne doprinose rešavanju problema u medijskom sektoru ili njegovom napretku, niti se sa izazovima u ovoj oblasti nose na adekvatan način. Donošenje Medijske strategije se odlaže u nedogled. Digitalizaciju i privatizaciju medija, vlast i dalje marginalizuje, iako su oba ova procesa značajna za razvoj medijskog sektora. Ono što posebno zabrinjava jeste povratak govora mržnje na medijsku scenu, ali i očigledan nedostatak volje vlasti da bilo šta nabolje promeni u medijskom sektoru.

***First, this Nineteenth Monitoring Newsletter starts with the most important news:***

**The monitoring of the media scene in Serbia continues in 2011!**

Having in mind that the past year has shown that the government is still not ready to seriously and responsibly deal with a number of problems and carry out quality reforms in this sector, ANEM, in cooperation with its long-time partner, the law office “Zivkovic&Samardzic”, continues the legal monitoring of the media scene, striving to provide guidelines for much needed changes that will enable the development of the more constructive media regulatory framework and creation of more favorable conditions for functioning of media and media

market in Serbia. ANEM is also continuing its follow-up promotional activities – by issuing a specialized Publication, organizing round tables, as well as creating and distributing *Monitoring Newsletters*. All monitoring reports, Publications and information on follow-up activities, will be made available for the general public on our website, in the special section “[Monitoring of the Media Scene](#)”.

In addition to this, here are the highlights of the most important monitoring news:

## **1. Read the Nineteenth Monitoring Report, published on ANEM website!**

This year's first Monitoring Report, but nineteenth in a row, brings the results of the legal monitoring of the Serbian media scene for the period January-February 2011.

The findings of the monitoring team point to the following:

Journalists and media in Serbia still do not have adequate conditions and environment for work. The pressures, threats and other forms of obstructing their work have continued, while the unchanged court practice in media cases have contributed to further deteriorating of already critical atmosphere. The number of journalists being put under continuous police protection has increased, including one representative of the civil sector. The regulatory framework in the reporting period has not been changed, which is not good news, since its shortcomings are still present and are affecting the media in an unfavorable manner in practice. The competent authorities are not contributing in any way to finding solutions for problems in the media sector, or to its development, and are unwilling to adequately deal with challenges in this area. The passing of the Media Strategy has been postponed yet again. Digitalization and privatization of the media are still marginalized by the authorities, although both these processes are highly important for the future development of the media sector. The particularly disturbing is the return of the hate speech to the media scene, as well as the evident lack of government's will to make any positive changes in the media sector.

ANEM, in cooperation with the law office “Zivkovic&Samardzic”, has been conducting the legal monitoring of the media scene in Serbia for 22 consecutive months, together with other follow-up activities.
