In this issue of Report, you can read, among other things, about:

- how strong were the political pressures exerted on media, as well as what was the court practice relating to responsibilities of media and journalists and the one in cases of attacks on media;
- why is the issue of allocation of budget funds intended for public information of local importance significant for media and why the Recommendations of the competent ministries, recently forwarded to local self-governments, have not actually brought any essential change in this area, in spite of this being their purpose in the first place;
- what solutions have been offered in the Draft Media Strategy and why they are important for the future development of the Serbian media sector, as well as what were the reactions to them during the public debate and why;
- why the conclusion of the process of privatization and withdrawal of the state from media ownership is important prerequisite for solving problems on the media scene and why such solution, provided in the Draft Media Strategy, has caused the most controversy during the public debate;
- why the transparency of media ownership is also important for the process of privatization of media in Serbia;
- why there has been no improvement in the Serbian media sector in this period.
